#### 1. Proof of your identity

Upload a clear and legible copy of <u>ONE</u> of the following documents (document cannot be accepted as valid where it has expired more than 6 months ago):

- <u>Passport</u> the identification page of your passport including your name, date of birth, photograph and signature; or
- <u>EU Driving Licence card</u> the identification side (photograph, name and signature) of your EU driving licence card.

#### 2. Proof of your address

- a letter from the Department of Employment Affairs and Social Protection or the Revenue Commissioners addressed to you;
- a letter from any other statutory body or State agency addressed to you; or
- a letter from an insurance company addressed to you relating to an existing insurance policy.

- European Health Insurance Card issued by the Government of Ireland (clearly showing and labelling YOUR PPSN)
